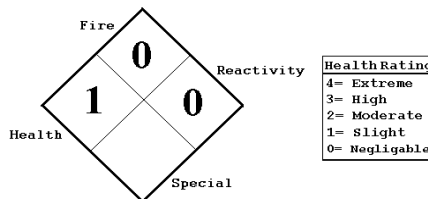

Section V Health Hazard Data

Eyes: Can cause mild to moderate irritation.

Ingestion: Seek medical attention. Unless advised otherwise, induce vomiting by giving either syrup of ipecac followed by 2 glassed of water or by sticking finger down throat. Do not give anything by mouth if the person is drowsy, unconscious or has no gag reflex.
